Residential Building Permit Fee Schedule

New Residential Construction:

Living area, garage, porch, finished basement, etc.: \$125.00 + \$0.08 per square foot

Unfinished basement: \$25.00

Additions: \$50.00 + \$0.08 per square foot

Accessory Buildings:

Unincorporated County and Cities without Zoning: Nebo, St. Charles, Nortonville

Less than 300 square feet	No Charge
300 – 500 square feet	\$50.00
Over 500 square feet	\$25.00 + \$0.08 per square foot

Cities with Zoning: Dawson Springs, Earlington, Hanson, Mortons Gap, White Plains

Less than 500 square feet	\$50.00
Over 500 square feet	\$25.00 + \$0.08 per square foot

Code Violation requiring re-inspection: \$25.00

NOTE: All agricultural structures are exempt from the permit and inspection requirements per KY Building Code and KY Residential Code with filing of completed affidavit.
